YouTube Compliance Cheat Sheet

Understanding YouTube's Guidelines for Cannabis Content

YouTube enforces strict community guidelines regarding cannabis-related content. Understanding these rules will help you avoid strikes, age restrictions, and demonetization while keeping your channel safe and growing.

What YouTube Allows & Restricts

Permitted Content (Low-Risk)

- Educational videos about cannabis science, law, or history
- News coverage on cannabis legalization and policies
- Documentary-style content about cannabis culture
- Discussions about personal experiences (without encouraging use)

Restricted Content (High-Risk)

- Encouraging or glorifying cannabis use
- Selling, linking to, or promoting cannabis products
- Step-by-step guides on how to grow, extract, or consume cannabis
- Showing minors using or being exposed to cannabis

YouTubes Three Types of Content Moderation

- 1 Age Restriction (18+ Only)
- Video is available but only to signed-in users over 18
- It wont appear in public search results
- Monetization is typically removed
- 2 Demonetization (Limited or No Ads)
- Video remains public but wont earn ad revenue
- You may still monetize via memberships, sponsorships, and affiliate marketing

YouTube Compliance Cheat Sheet

- 3 Takedown (Strike or Removal)
- Video is removed, and a strike is issued
- Three strikes within 90 days result in channel termination

How to Keep Your Content Compliant

- Frame your videos as educational or documentary-style
- Blur or censor cannabis-related visuals when necessary
- Use alternative wording (e.g., 'herbal remedies' instead of 'weed')
- Avoid links to cannabis-related sales sites
- Use disclaimers: 'For educational purposes only. No sales or promotions.'

Appeal Process (What to Do if You Get Flagged)

If your video gets age-restricted, demonetized, or removed, you can appeal.

Steps to Appeal a Strike or Takedown:

- 1 Review YouTubes guidelines to see if a policy was actually violated.
- 2 Go to YouTube Studio Select the flagged video Click Appeal.
- 3 Use a professional and factual appeal message.
- 4 If the appeal is denied, consider re-editing & re-uploading with compliance fixes.
